- 5. Must indicate information on educational qualifications and other qualifications correctly. Copies of the related certificates should be attached with the application for proof.
- 6. Employment and conditions of employment
 - I. Appointment will be on contact basis only for a period of 3 years
 - II. A monthly allowance of Rs.33, 600 will be paid.

Having passed G.C.E. O/L examination in six (6) subjects including Dancing with two credit passes in not more than two attempts.

Having Completed the Diploma course on Dancing conducted by the National Youth Services Council, Sri Lanka

or

Having Completed the Dancing Study Course by Fork Art Centre ('Jana kala Kendraya')

or

Having Passed the National Dancing Prarambha Examination

or

Having any other Diploma in related to the subject similar to above qualifications which will be accepted by the Director of Department of Cultural Affairs.

III. Experience

03 Year experience at a government approved Art Institute or a similar institute as a dancer.

or

Must be a traditional dancer (must prove in written)

- IV. Physical Qualification
 - i. Every applicant must be physically and mentally sound to fulfill the duties of the position and to be serve in any area within the country.
 - ii. Height must not less than 5 ft. and 2 inches.
- V. Other Qualifications
 - i. Every applicant must be physically sound and of excellent moral character
 - ii. Every qualification requested for the recruitment must be completed in all terms on the last date of receipt of application
 - iii. Proficiency in dance/instrumental will be considered
- 8. Age limit: Should not less than 18 years and not more than 25 years on the last date of receipt of application.
- 9. Recruiting procedure
 - Will recruit based on the results of an Aptitude assessment interview and a Practical Examination.
 - In order of merit at the Aptitude assessment interview, number of applicants twice the number of vacancies will be called for the practical examination. Recruitment for the position will be done in order of merit based on the total marks achieved in both the Aptitude assessment interview and the Practical examination.
